Notes

This table shows what we paid to firms for each solicitor advocate between 1 April 2010 and 31 March 2011. Amounts are rounded to the nearest £100. It includes BACS payments transferred to the firms' bank accounts and cheques dated between those dates. In some cases, money may have been paid to a firm, but returned to us, and any such amounts put through our accounts system between those dates have been deducted. If a firm has repaid us money in a year later than the original payment, they may be shown as having been paid a negative figure. A further 3 solicitor-advocates received payment from the Board of less than £100. This totalled £203. If a solicitor advocate has been paid with more than 1 firm each firm is shown separated by a semi-colon.
