The Committee was asked to consider whether the tests of probable cause and

The Committee discussed at length the issue of whether a time bar applied in this case, focussing on whether there was a continuing wrong or not and that this should

be tested in the court. It was noted that this was a Sheriff Court action and therefore the time bar issue, being a preliminary matter, would be settled quickly thus potentially limiting the legal aid expenditure.

The Committee were of the view that there was a public policy interest in this case and that local authorities need to be held accountable for their actions. Although the action for damages was questionable they felt that if the court made a declaratory award under the Human Rights Act 1998 against Glasgow City Council then that would fulfil the requirement to hold them to account.

The Committee acknowledged that if the time bar matter did not fall at the preliminary stage then the grant would be for the full action. It was therefore decided that a formal condition be attached to such a grant requesting stage reports if the preliminary phase on the time bar was successfully overcome.

The Committee therefore agreed that there was merit in litigating the public policy aspect and testing the issue of the time bar in court. The time bar issue would be a useful matter to test for future reference.

The Committee DECIDED to GRANT the application subject to the provision of stage reports should the case proceed beyond the preliminary stages.
