All figures are fees £000, ex VAT and show what was paid directly to solicitors' firms by the Scottish Legal Aid Board between 1 April 2020 and 31 March 2021. Values are rounded to the nearest £1000.

Fees paid comprise solicitor and solicitor-advocates fees.

They include electronic payments transferred to the firms' bank accounts and cheques dated between those dates. In some cases, payments may have been returned to us, and any such amounts put through our accounts system between those dates have been deducted.

Firms receiving payment from SLAB of less than £25000 have not been shown.
