Notes

- This table shows what we paid to firms for each solicitor advocate between 1 April 2006 and 31 March 2007.
- It includes BACS payments transferred to the firms' bank accounts and cheques dated between those dates.
- In some cases, money may have been paid to the firm, but returned to us, and any such amounts put through our

accounts system between those dates have been deducted. If a solicitor advocate has repaid us money in a year later than the original payment, they may be shown as having been paid a negative figure.

- Amounts are rounded to the nearest £100.
- A further 1 solicitor advocate received payment from the Board of less than £100. This totaled £50.
