## CHANGE OF CONTACT DETAILS FOR ORDERING LEGAL AID FORMS AND LEAFLETS

*Please make any staff involved with legal aid work in your office aware of this change.*

Contact details for ordering legal aid forms and leaflets have now changed. The Board's printer, Stewarts, have recently moved from Edinburgh to Livingston. Whilst calls will be forwarded for a period, please now use the following new contact details for ordering legal aid materials:

A new order form for legal aid materials is attached. The best way to order is to complete the form and fax it to Stewarts. Orders will be sent to you within 5 working days.

You can also now order from Stewarts further copies of the Keycard, Category Codes Card for advice and assistance, and Equality Card for advice and assistance. These are now listed on the second page, together with leaflets.

Please note that we will be issuing a new version of the Keycard for April, when the annual eligibility limits changes are made. The new version of the Keycard will be *automatically sent* to legal aid solicitors. You will therefore only need to order Keycards from Stewarts where you wish *additional* copies.
