Note
 This table shows what we paid to firms for each solicitor advocate between 1 April 2016 and 31 March 2017. It comprises electronic payments transferred to the firms' bank accounts and cheques dated between those dates. In some cases, money may have been paid, but returned to us, and any such amounts put through our accounts system between those dates have been deducted. Amounts are rounded to the nearest £1000. Solicitor advocates receiving payment from SLAB of less than £1000 have not been shown. If a solicitor advocate has been paid with more than one firm each firm is shown separated by a semi-colon.
